# Subsidies Applicable for Convention Expenses

**Eligible Period** **Apr. 1<sup>st</sup>, 2019 - Mar. 31<sup>st</sup>, 2022**

## Requirements

Must fulfil either of the following conditions.

### Condition A

- Rotates at least between 3 countries
- Occurs regular basis
- Attracts a minimum of 50 participants from overseas

### Condition B

- Attracts 100 or more participants from outside of Okinawa
- Be held for 2 days or more
- The location should be pending

## Amount

The amount of the subsidy is half of the eligible expenses. The final amount of the subsidy will be determined by OCVB regarding the submitted report.
